Each contestant can complete the story however they like, and thus be permitted to enter the final competition.

The competition is open to two groups of contestants: FAMILIES and ADULTS. Contestants in the FAMILY group have to submit a description of the missing statue (either in writing or as a drawing) and a short story suggesting a solution to the mystery of the missing statue. They also have to describe very briefly how each member of the family contributed. Contestants in the ADULT group have to submit a description of the missing statue (either in writing or as a drawing) and a short story incorporating the role they have played.

Please specify which of the two groups you are submitting your entry for on the envelope.

Entries must be submitted no later than 21 June 2015. The entry in each group judged to be the best by a panel of archaeologists, art historians and experts selected by the Fondazione Palazzo Strozzi will win a three-day trip to Athens including a return flight and two nights in a hotel. For the FAMILY group the prize is for four people (two adults and two children/teenagers), and for the ADULT group the prize is for two people.

The stories judged to be the best will be published online at www.palazzostrozzi.org after the winners have been announced on 30 June 2015.

This competition for the production of a description of the missing statue (in writing or as a drawing) and of a short story consistent with the role played (no more than 3,000 keystrokes including spaces) is organised as part of the exhibition entitled *Power and Pathos: Bronze Sculpture of the Hellenistic World* (Florence, Palazzo Strozzi, 14 March 21 June 2015), by the Fondazione Palazzo Strozzi whose registered office is situated in Palazzo Strozzi, Piazza Strozzi, 50123 Florence, Italy.

Duration

From 14 March to 21 June 2015. Deadline for submission of the entry form attached to this announcement, which must be accompanied by a description of the missing statue (in writing or as a drawing) and by an original short story consistent with the role played: 21 June 2015.

Announcement of the winner: 30 June 2015.

Qualifying Entrants

No restrictions apply. Families, individuals, children and teenagers may all enter the competition, although the authorisation of a parent or guardian is required for entrants under 18 years of age.

Procedure

The jury will only judge entries from entrants:

1. who have registered for the competition before the deadline by fully and correctly completing the entry form below;

2) who have submitted their original entry (a description of the missing statue, in writing or as a drawing, and a short story consistent with the role played) devised and written either individually or by a family group.

Entry forms and stories may be submitted either in Italian or in English. No stories written in any other language will be taken into consideration.

Entrants may not request that material submitted be returned to them.

Entrants under the age of 18 taking part in the competition must be authorised to do so by their parents of guardians, both to take part and, if relevant, to accept and to make use of the prize.

The entry (comprising a description of the missing statue, in writing or as a drawing, and a short story) proclaimed the winner will be awarded the following prize:

a three-day trip to Athens, including a return flight in economy class and two nights in a three-star hotel for a maximum of four people (two adults and two children/teenagers) in the FAMILY group, and for a maximum of two people in the ADULT group.

Prizes will be awarded to the entry (consisting of a description of the missing statue, in writing or as a drawing, and a short story) held to be the best in each of the two groups by a qualified jury comprising archaeologists, art historians and experts in the field

Informing Winners and Collection or Delivery of Prizes

The winner will be informed, using the details provided by the entrant on his or her entry form, no later than two weeks after the jury has convened to judge the competition.

The winning entrant will receive an e-mail which he or she must answer within 15 days, either (a) confirming that he or she wishes to accept the prize in person, or (b) providing an address to which the prize may be delivered.
